The book begins by considering the translation of human rights discourse into labor standards, namely how theory might be put into practice. The remainder of the book tests hypotheses posited in the first chapter and is divided into three parts. The first part investigates, through a number of national case studies, how, in practice, workers' rights are treated as human rights in the domestic legal context. These chapters cover European, Pacific, American, Asian, and African countries. The second part consists of essays which analyze the operation of regional or international systems for human rights promotion and their particular relevance to the treatment of workers' rights as human rights. The final part consists of chapters which explore regulatory alternatives to the traditional use of human rights law. The book concludes by considering the merits of various regulatory approaches.
